Safe Sport - discussion lead by Jen

Jen discussed, on behalf of DTSS PAC, the interest that we have regarding the inclusion of Safe Sport policy in DTSS. Presented was:

- a summary of issues and why this policy may be helpful

- a descriptor of the presentation that Christine and Chenoa gave to the Trustees
- the letter, written by Jen on behalf of the PAC Board, that was sent to the Trustees (attached)

The Trustees were interested and concerned. They decided to have the Policy Sub-committee review this idea.

Since then, I have received a letter confirming that the Policy Sub-committee is reviewing.

DPAC reps were very interested in our request. They want to see the letter. They are interested to send in a letter of support in the future. They asked if Christine and Chenoa could do a presentation to them. They also feel that there would be many clubs/ groups where Safe policy would be important, not just athletics.

Christine to attend next DPAC (and answer questions re Safe Sport).

Information from Acting Superintendent Steve Wyer

- Hiring for a Superintendent will commence. The DPAC will have a representative involved.
- Child abuse report training Efforts have been underway to make the reporting easier (both to access and submit). There will be a link to your community with a form.
- Volunteers will need to understand that they are representing SD6.
- Cell phone restriction guidance will be in place for September. It will not be a ban.
- Chronic absenteeism is a concern. There has been some research and results are available for SD6.
- District website The DPAC can put content on the District website. Just ask Steve Wyer.
- Framework for Enhanced Student Learning (also strategic plan, engagement plan) is on there (on Distric Website) . These are important for DPAC to consider because we may see areas where we can do things better in the SD. The info here is replicated for each school and we can request it .
